Mr. David McCune, Chairman, presented the Committee's report to the Board.

# <u>Approval of Lease to Cumberland County and Declaration of Property as Temporarily Unnecessary or Undesirable for College Purposes</u>

The County requested office space for Economic Development Operations.

- Coordination identified specific office needs.
- The College will lease 1,448 gross square feet in the Center for Business and Industry Building.
- The College will lease space to the County on lease with three one-year renewal options.
- The County will reimburse the College for operational costs.

Dr. Keen stated that the Alliance and College working more closely will elevate the relationship to new heights. Mrs. Cannon stated the lease will be a great extension of the relationship. Mr. Rogerson stated FTCC is a key partner and lease will make relationship stronger.

On the recommendation of the Building and Grounds Committee, Mr. McCune moved to approve lease to Cumberland County and declaration of property as temporarily unnecessary or undesirable for college purposes. The motion was unanimously approved by the Board.

### Horace Sisk Renovation (Information only)

- Renovations will be made in the following areas:
  - The rear hallway that leads to the Culinary Dining Room.
  - The men and women's restrooms off the breezeway leading to the Culinary Dining Room.
  - Exterior doors replaced and card access readers installed with automatic locking capabilities.
  - Dean and faculty offices.
- Projected cost \$400,000.
- Projected completion Summer 2016.

<u>Curriculum Committee</u> The Curriculum Committee met at 10:40 a.m. prior to this meeting. Dr. Dallas M. Freeman, Chairman, presented the Committee's Report to the Board.

# <u>Approval of Captive Location – C & C Outreach Services, 916 Hope Mills Road, Fayetteville, NC 28304</u>

The NC Community College System requires approval for the courses taught in Basic Skills, Occupational Extension, Human Resources Development and Community Services when offered with controlled groups.

- Captive students are students that receive instruction as:
  - 1. Inmates in a NC Department of Correction Facility
  - 2. Inmates in a Private Correction Facility.
  - 3. Inmates in a Federal Correction Facility.
  - 4. Inmates in a Local Jail/Detention Center.
  - 5. Clients of Domiciliary Care Facilities.
  - 6. Clients of Substance Abuse Rehabilitation Center.
  - 7. Clients of Community Rehabilitative Facility/ADAP Center.
  - 8. Clients of a Nursing Facility.
  - 9. In-patients of a Psychiatric Hospital.
  - 10. Juveniles of DJJDP (committed youth).
- Each class has an outline, specific learning objectives, and an evaluation method
- FTCC will proved ABE 2000U, Adult Basic Education at the program site.
- The proposed implementation date is January 4, 2016.
- Class meetings will be 5 times weekly with 6 hours on Monday Thursday and 4 hours on Friday.

On the recommendation of the Curriculum Committee, Dr. Freeman moved to approve Captive Location – C & C Outreach Services, 916 Hope Mills Road, Fayetteville, NC 28304. The motion was unanimously approved by the Board.

<u>Finance Committee</u> The Finance Committee met at 10:45 a.m. prior to the meeting. Mr. William S. Wellons, Jr., Chairman, presented the Committee's report to the Board.

# Notification of Tuition Rate Increase – effective Spring 2016. Revision to Academic Procedures Manual III-4.1 (1) Tuition, Fees, and Books

Tuition, Fees, and Books

(1) Tuition (effective Spring 2016):

a. In-State Tuition: \$76.00 per credit hour, up to 16 hours\* or;

\$1,216.00 per semester, or; \$2,432.00 for two semesters

b. Out-of-State Tuition: \$268.00 per credit hour, up to 16 hours\* or;

\$4,288.00 per semester, or; \$8,576.00 for two semesters

(2) Fees

- a. Certain curricula require additional costs to cover items which may include uniforms, instruments, tools, malpractice insurance, and dues to student association groups.
- b. On-campus parking is described in the Parking Regulations Bulletin. Parking stickers are issued on payment of fees at registration. STUDENTS ARE HELD RESPONSIBLE FOR ALL PARKING REGULATIONS AS STATED IN THE PARKING REGULATIONS BULLETIN.
- c. All prospective graduates will be charged a graduation fee of \$25.00 for each certificate or diploma. One exception is High School students enrolled under the Career and College Promise Program are exempt from paying a graduation fee. Adult high school graduates will be charged a fee of \$35.00 for a current diploma and a fee of \$45.00 for a back-dated diploma.
- d. Replacement of lost or stolen ID card fee of \$5.00.
- e. Continuing Education Registration Fees:

Course LengthRegistration Fee0-24 Hours\$ 70.0025-50 Hours\$125.0050+ Hours\$180.00

Certain Continuing Education programs require specific fees to cover additional costs associated with the program.

- f. Student Activity Fee of \$14.00 per semester for Fall and Spring terms and \$10.00 for Summer term.
- g. Technology Fee of \$16.00 per semester.
- h. Campus access, parking, security (CAPS) fee of \$15 per semester.
- (3) Books (Estimated): \$750 per semester

On the recommendation of the Finance Committee, Mr. Wellons moved to approve notification of tuition rate increase – effective Spring 2016 and revision to Academic Procedures Manual 111-4.1 (1). The motion was unanimously approved by the Board.

Request approval of Combined Budget (DCC 2-1 Form for Fiscal Year 2015-2016 Mr. Wellons reported the Combined Budget of \$135,892,232 (State, County and Institutional funds) is required by the NC Community College System for State Board approval.

On the recommendation of the Finance Committee, Mr. Wellons moved to approve the Combined Budget (DCC 2-1 Form for Fiscal Year 2015-2016. The motion was unanimously approved by the Board.

# Approval of the Resolution of the Board of Trustees of Fayetteville Technical Community College
