Continuing Education Drone Training Opportunities

FTCC Corporate and Continuing Education began offering Drone Training for beginners

in the Spring of 2017.

- Since its inception, seven courses have been offered.
- Three one-day workshops have been offered.
- Enrollment: Fifty-nine (59) people have taken the course.
- In the Fall of 2018, in partnership with NCDOT, a Drone Workshop was offered and 173 people attended this event.
- The Small Business Center offers How to Start a Drone Business Seminar.
- Additional discussions are taking place to offer Drone Training in Emergency Protective Service arena and investigating a Drone Maintenance program.
