PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for 1st session registrations made **March 28th – August 6th** are due by **5 p.m. on Monday, August 6, 2018.**

Payments for 1st session registrations made **August 7th – August 13th** are due by **5 p.m. on Monday, August 13, 2018.**

Payments for 1st session registrations made **August 14th – August 18th** are due by **12 noon on Saturday, August 18, 2018.**

Payments for 4-week session registrations made **March 28th – August 31st** are due by **4:30 p.m. on Friday, August 31, 2018.**

Payments for 4-week session registrations made **March 28th – October 1st** are due by **4:30 p.m. on Monday, October 1, 2018.**

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan through your WebAdvisor account constitutes payment and will hold your courses.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.
