PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for Fall II registrations made **September 4th – October 8th** are due by **5 p.m. on Monday, October 8, 2018.**

Payments for Fall II registrations made **October 9th – October 16th** are due by **5 p.m. on Tuesday, October 16, 2018.**

Payments for Fall II registrations made **October 17th** are due by **4 p.m. on Wednesday, October 17, 2018.**

Payments for 4-week session registrations made **Sept 4th – October 31st** for classes starting November 1st are due by **4 p.m. on Wednesday, October 31, 2018.**

Payments for 4-week session registrations made **Sept 4th – December 2nd** for classes starting December 3rd are due by **4 p.m. on Friday, November 30, 2018.**

NOTES: *If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.*

- *Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.*
- *Enrollment in the Tuition Payment Plan through your WebAdvisor account constitutes payment and will hold your courses.*
- *Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.*

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.
