PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for registrations made **October 23rd – January 3rd** are due by **5 p.m. on Wednesday, January 3, 2018.**

Payments for registrations made **January 4th – January 10th** are due by **5 p.m. on Wednesday, January 10, 2018.**

Payments for registrations made **January 11th – January 12th** are due by **5 p.m. on Friday, January 12, 2018.**

Payments for registrations made **January 13th – January 15th** are due via WebAdvisor by **12 midnight January 15, 2018.**

NOTES: *If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.*

- *Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.*
- *Enrollment in the Tuition Payment Plan constitutes payment and will hold your courses.*
- *Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.*

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.
