PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for registrations made **October 20th – January 5th** are due by **5 p.m. on Tuesday, January 5, 2021.**
 Payments for registrations made **January 6th – January 9th** are due by **12 noon on Saturday, January 9, 2021.**

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan through your WebAdvisor account constitutes payment and will hold your courses.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.

****ACTIVE DUTY SOLDIERS (Army Tuition Assistance Registration) will take place via WebAdvisor. Soldiers still need to use the GoArmyED web portal to secure tuition assistance prior to the start date of class.**
