PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for 2nd 8-week session registrations made **January 28th – March 6th** are due by **5 p.m. on Wednesday, March 6, 2019.**
Payments for 2nd 8-week session registrations made **March 7th – March 13th** are due by **5 p.m. on Wednesday, March 13, 2019.**

Payments for 4-week session registrations made **January 28th – March 29th** for classes starting April 1st are due by **4:30 p.m. on March 29, 2019.**

- NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.**
- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
 - **Enrollment in the Tuition Payment Plan constitutes payment and will hold your courses.**
 - **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

To avoid being charged tuition and fees for your dropped courses, it is your responsibility to confirm that your courses have been dropped prior to the start date of class by checking your WebAdvisor account.
