#### 1<sup>st</sup> Session

Payments for registrations made **March 28<sup>th</sup> – May 21<sup>st</sup>** are due by **5 p.m. on Monday, May 21, 2018.**

Payments for registrations made **May 22<sup>nd</sup> – May 25<sup>th</sup>** are due by **12 noon on Friday, May 25, 2018.**

Payments for registrations made **May 26<sup>th</sup> – May 28<sup>th</sup>** are due via WebAdvisor by **12 midnight on Monday, May 28, 2018.**

#### 2<sup>nd</sup> Session

Payments for registrations made **March 28<sup>th</sup> – June 15<sup>th</sup>** are due by **12 noon on Friday, June 15, 2018.**

**NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.**

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan constitutes payment and will hold your courses.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

**To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.**
