PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for 1st session registrations made **March 15th – May 13th** are due by **5 p.m. on Monday, May 13, 2019.**

Payments for 1st session registrations made **May 14th – May 20th** are due by **5 p.m. on Monday, May 20, 2019.**

Payments for 1st session registrations made **May 21st – May 27th** are due via WebAdvisor by **12 midnight on Monday, May 27, 2019.**

Payments for 2nd session registrations made **March 15th – June 16th** are due via WebAdvisor by **12 midnight on Sunday, June 16, 2019.**

Payments for 4-week session registrations made **March 15th – June 2nd** for classes starting June 3rd are due via WebAdvisor by **12 midnight on Sunday, June 2, 2019.**

Payments for 4-week session registrations made **March 15th – June 30th** for classes starting July 1st are due via WebAdvisor by **12 midnight on Sunday, June 30, 2019.**

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.

- Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.
- Enrollment in the Tuition Payment Plan constitutes payment and will hold your courses.
- Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.

To avoid being charged tuition and fees for your dropped courses, it is your responsibility to confirm that your courses have been dropped prior to the start date of class by checking your WebAdvisor account.
