Good Morning and I hope you are having a great Fall 2017 Semester.

FTCC provides information to all employees and students annually related to Title IX, Violence Against Women Act (VAWA), Gender discrimination, Sexual Harassment, Sexual Assault, Dating/Domestic Violence and Stalking as part of our ongoing education awareness process. Key points of this annual education awareness program are listed below:

- *Title IX of the Education Amendments of 1971* prohibits discrimination based upon sex/gender in education programs and activities that receive federal financial assistance. Examples of the types of discrimination that are prohibited under Title IX include sexual harassment, sexual assault/sexual violence, pregnancy discrimination, and failure to provide equal opportunity in athletics or other College programs and activities. VAWA provides protections to individuals who are the target of sexual violence, domestic violence, and stalking. The College has a website focused on Title IX and Equal Opportunity which includes definitions, Title IX points of contact, and complaint processes.  - Counseling services are available for individuals seeing assistance with crisis issues.
