

## Cardiovascular Monitor Technician

An official High School Transcript or GED must be received **prior to the first business day of class starting.**


- Official transcripts must be received directly from the institution to be considered official transcripts can be sent to one of the following ways:
  - Hand carried: Tony Rand Student Center (TRSC) Room #2- In a sealed envelope from the issuing institution.
  - Mailed: Fayetteville Technical Community College Evaluation Office, P.O. Box 35236, 2220 Hull Road, Fayetteville, NC 28303
  - Electronic Transfer by E-Script: [evaltranscripts@faytechcc.edu](mailto:evaltranscripts@faytechcc.edu).

**Students who fail not to provide the official transcript by this deadline will be dropped from the course.**

- If the student does not have the unofficial transcript at the time of registration, they will be allowed to register but will have 3 business days from the date they register to provide the unofficial copy.
- **If not received by the 3<sup>rd</sup> business day, the student will be dropped from the course.**
- International transcript **must be professional translated and evaluated by one of the credentialing agencies.** (If needed, please send an email to [healthprograms@faytechcc.edu](mailto:healthprograms@faytechcc.edu).)

Students must attend the **1<sup>st</sup> day of class**. Failure to attend by the **2<sup>nd</sup> day of class** will result in automatic withdrawal from the program. Students must also attend the **LAST DAY OF CLASS**.

- **Most health programs use online components such as Blackboard, therefore, laptops are strongly recommended.**

- **Uniform:** Students are required to wear scrubs on the first day of class and duration of the course: (Black tops and bottoms) with white or black socks and black leather sneaker type shoes.

**Upon successful completion of this program, the student should be prepared to take the National Certification Exam at an additional fee.**

**REFUND POLICY:** If you withdraw prior to the **1<sup>st</sup> day of class** you may be eligible for a 100% refund. If you withdraw on or after the **1<sup>st</sup> day of class**, you may be eligible for a 75% refund of the registration fee if requested prior to the 10% date.
