- NOTES:** *If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.*
- *Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.*
 - *Enrollment in the Tuition Payment Plan through your Self-Service account constitutes payment and will hold your courses.*
 - *Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.*

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your Self-Service account. You may be charged a fee for your dropped courses if you drop your courses on or after the first day of the semester/term.

****ACTIVE-DUTY SOLDIERS (Army Tuition Assistance Registration) – all Active-Duty Soldiers must register via FTCC Self-Service and request tuition assistance 7 days prior to the class start date.**
