PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for registrations made **August 2nd – October 6th** are due by **5 p.m. on Wednesday, October 6, 2021.**

Payments for registrations made **October 7th – October 13th** are due by **5 p.m. on Wednesday, October 13, 2021.**

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan through your Self-Service account constitutes payment and will hold your courses.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your Self-Service account. You may be charged a fee for your dropped course if you drop your course on or after the first day of the semester/term.

****ACTIVE DUTY SOLDIERS (Army Tuition Assistance Registration) will take place via Self-Service. Soldiers still need to use the ArmyIgnitED web portal to secure tuition assistance 5 days prior to the start date of class.**
