### PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for 1<sup>st</sup> session registrations made **March 24<sup>th</sup> – May 18<sup>th</sup>** are due by **5 p.m. on Friday, May 16, 2025** if paying at the cashier's office or by **midnight on Sunday, May 18, 2025** if paying on Self-Service.

Payments for 1<sup>st</sup> session registrations made **May 19<sup>th</sup> – May 26<sup>th</sup>** are due by **1 p.m. on Friday, May 24, 2025** if paying at the cashier's office or by **midnight on Monday, May 26, 2025** if paying on Self-Service. **Payments for registrations made May 27<sup>th</sup> - May 31<sup>st</sup> are due at the time of registration.**

Payments for 2<sup>nd</sup> session registrations made **March 24<sup>th</sup> – June 2<sup>nd</sup>** are due by **1 p.m. on Friday, May 30, 2025** if paying at the cashier's office or by **midnight on Sunday, June 1, 2025** if paying on Self-Service.

Payments for 2<sup>nd</sup> session registrations made **June 2<sup>nd</sup> - June 8<sup>th</sup>** are due by **1 p.m. on Friday, June 6, 2025** if paying at the cashier's office or by **midnight on Sunday, June 8, 2025** if paying on Self-Service. **Payments for registration made June 9<sup>th</sup> - June 13<sup>th</sup> are due at the time of registration.**

**NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.**

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan through your Self-Service account constitutes payment and will hold your courses.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

**To avoid being charged tuition and fees, it is your responsibility to confirm that your courses have been dropped prior to the first day of the semester/term by checking your Self-Service account. You may be charged a fee for your dropped courses if you drop your courses on or after the first day of the semester/term.**

**\*\*ACTIVE DUTY SOLDIERS (Army Tuition Assistance Registration) – all Active Duty Soldiers must register via FTCC Self-Service and request tuition assistance 7 days prior to the class start date.**
