PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for 1st session registrations made March 24th – May 18th are due by <u>5 p.m. on Friday, May 16, 2025</u> if paying at the cashier's office or by <u>midnight on Sunday, May 18, 2025</u> if paying on Self-Service. Payments for 1st session registrations made May 19th – May 26th are due by <u>1 p.m. on Friday, May 24, 2025</u> if paying at the cashier's office or by <u>midnight on Monday, May 26, 2025</u> if paying on Self-Service. Payments for registrations made May 26th are due by <u>1 p.m. on Friday, May 24, 2025</u> if paying at the cashier's office or by <u>midnight on Monday, May 26, 2025</u> if paying on Self-Service. Payments for registrations made May 27th - May 31st are due at the time of registration.

Payments for 2nd session registrations made March 24th – June 2nd are due by <u>1 p.m. on Friday, May 30, 2025</u> if paying at the cashier's office or by <u>midnight on Sunday, June 1, 2025</u> if paying on Self-Service. Payments for 2nd session registrations made June 2nd - June 8th are due by <u>1 p.m. on Friday, June 6, 2025</u> if paying at the cashier's office or by <u>midnight on Sunday, June 8, 2025</u> if paying on Self-Service. Payments for registration made June 9th - June 13th are due at the time of registration.

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.
